If you record an event, make sure to:

- 1. Collect **consent from the speakers before the event** → ideally at the time of registration (see template next page)
- 2. Collect consent from participants and inform them before the event that only the presentation(s) will be recorded, for what purpose the recording will be used and advise them to turn off their cameras during the event. Neither regular Participants' videos/images nor personal data (i.e. names) should be recorded as a general rule!
- 3. **Crop/Blur** participants' names, pictures and any other personal data information, should they be visible in any recording BEFORE the video is further processed or published.
